



## **Amplify ETFs to Liquidate the Amplify U.S. Alternative Harvest ETF (MJUS)**

**January 8, 2025 – Chicago, IL** - Amplify ETFs, a leading provider of exchange traded funds, today announced the scheduled liquidation of the Amplify U.S. Alternative Harvest ETF (NYSE Arca: MJUS) (the “Fund”).

Based on the recommendation of Amplify Investments LLC, the Fund’s investment adviser, the Board of Trustees of the Amplify ETF Trust unanimously determined that it is in the best interests of the Fund and its shareholders to liquidate the Fund.

The Fund will no longer accept creation orders after the close of business on January 20th, 2025. Shareholders may sell their shares in the Fund prior to the end of trading on January 27th, 2025. Customary brokerage charges may apply to these transactions. The Fund will cease trading at the end of the trading day on January 27th, 2025.

The Fund will be liquidated and a final distribution to shareholders of the Fund is expected to occur on or around January 30, 2025. Any person holding shares in the Fund as of the liquidation date will receive a cash redemption amount equal to the net asset value of their shares as of that date. Shareholders will generally recognize a capital gain or loss on any redemption.

Amplify Investments will bear all fees and expenses that may be incurred in connection with the liquidation of the Funds and the distribution of cash proceeds to investors, other than brokerage fees and other related expenses.
